# Instructions

## **Pressure Relief Procedure**









#### SKIN INJECTION HAZARD

The system pressure must be manually relieved to prevent the system from starting or spraying accidentally. Fluid under high pressure can be injected through the skin and cause serious injury. To reduce the risk of an injury from injection, splashing fluid, or moving parts, follow the **Pressure Relief Procedure** whenever you:

- · are instructed to relieve the pressure,
- stop working,
- check or service any of the system equipment,
- · install or clean the accessory.

- Hold a metal part of the gun firmly to a grounded metal pail. Trigger the gun to relieve pressure.
- 5. Engage the trigger lock.
- Open all fluid drain valves, having a waste container ready to catch drainage. Leave drain valve(s) open until you are ready to spray again.
- 7. If you suspect the spray tip or hose is clogged or that pressure has not been fully relieved:
  - a. VERY SLOWLY loosen tip guard retaining nut or hose end coupling to relieve pressure gradually.
  - b. Loosen nut or coupling completely.
  - c. Clear hose or tip obstruction.

## 1. Engage trigger lock.

- Shut off the power supply to the pump and open any air bleed valves in the system.
- 3. Disengage the trigger lock.

#### NOTICE

Do not use extensions in combinations beyond 14 ft (4.27 m). Extensions used in combination beyond 14 ft (4.27 m) may result in equipment damage.

## Installation



### **FIRE AND EXPLOSION HAZARD**

Do not use 1,1,1-trichloroethane, methylene chloride, other halogenated hydrocarbon solvents or fluids containing such solvents in pressurized aluminum equipment. Such use could result in a chemical reaction, with possibility of explosion.

Gasket (6) must be in place before installing frame (1). If gasket is not in place there is a potential injection hazard which could result in serious injury.

Refer to your sprayer and spray gun manuals for appropriate warnings and instructions for safe operation of this extension.

- Follow Pressure Relief Procedure on page 1.
- 2. Install heavy duty extension on spray gun. Wrench tighten with two wrenches.
- Install accessory. Wrench tighten with two wrenches.
- 4. Prime pump.




